OP14-001	Trafalgar Law	Can I use this [Activate: Main] effect to swap the base power of my character with that of an opponent's Character, or to swap the base powers of two of my opponent's Characters?	No, you cannot.
OP14-001	Trafalgar Law	If one of the Characters I've selected with this [Activate: Main] effect would be removed from the field, does the power of the Character that remains on the field revert to its original value?	No. That Character's power does not revert to its original value and maintains the swapped value until the end of that turn.
OP14-001	Trafalgar Law	After using the [Once Per Turn] effect of my "PRB02-002 Trafalgar Law", I then use this [Activate: Main] effect to swap the power of "PRB02-002 Trafalgar Law" with that of "OP14-013 Monkey.D.Luffy". In this situation, what would the power of "PRB02-002 Trafalgar Law" become?	The base power of "PRB02-002 Trafalgar Law" would become 0, and since the effect from "PRB02-002 Trafalgar Law" is giving -2000 power, the card's power would be -2000.
OP14-002	Urouge	When I activate this [When Attacking] effect, if this Character's power is 4000 or less, can I K.O. up to 1 of my opponent's Characters with 3000 base power or less?	No, you cannot.
OP14-003	Capone" Gang" Bege	"OP13-084 St. Shepherd Ju Peter" is on the field, and I played "OP13-091 St. Marcus Mars" when I have 10 or more cards in my trash. Since the base power of "St. Marcus Mars" becomes 7000, can I use its [On Play] effect to K.O. this card?	Yes, you can.
OP14-009	Trafalgar Law	Can I select my Leader and 1 of my opponent's Characters with this [On Your Opponent's Attack] effect?	No, you cannot.

OP14-017	Chambres	If one of the Characters I've selected with this [Main] effect would be removed from the field, does the power of the Character that remains on the field revert to its original value?	No. That Character's power does not revert to its original value and maintains the swapped value until the end of that turn.
OP14-020	Dracule Mihawk	During a turn in which I use this [Activate: Main] effect to set 3 of my DON!! cards as active, can I play Character cards using other effects?	No, you cannot.
OP14-020	Dracule Mihawk	When this card's [Activate: Main] effect says "You may rest 1 of your cards", what kind of cards can I rest to activate this effect?	You can activate this effect by resting 1 of your active Leader, Character, Stage, or DON!! cards.
OP14-021	Issho	Does the "When this Character becomes rested" effect activate when this Character attacks?	Yes, it does. When this character attacks, the activation timing is fulfilled at the same time as other effects such as [When Attacking].
OP14-024	Kin'emon	When this card's [On K.O.] effect says "Rest up to 1 of your opponent's cards", what kind of cards can I rest with this effect?	This effect allows you to rest 1 Leader, Character, Stage, or DON!! card on your opponent's field that is active.
OP14-027	Shanks	Does the "When this Character becomes rested" effect activate when this Character attacks?	Yes, it does.
OP14-028	Johnny	Does the "When this Character becomes rested" effect activate when this Character attacks?	Yes, it does.

OP14-029	Tashigi	When this card's [Activate: Main] effect says "You may rest 2 of your cards", what kind of cards can I rest to activate this effect?	You can activate this effect by resting a total of 2 of your active Leader, Character, Stage, and/or DON!! cards on your field.
OP14-029	Tashigi	Can I use these [Opponent's Turn] or [Activate: Main] effects to rest this "Tashigi" card itself?	Yes, you can.
OP14-031	Nami	When 5 or more of my DON!! cards are rested, can I use this card's [On Play] effect to set 4 or less of my rested DON!! cards as active?	Yes, you can. At the end of the turn you activated this Character's [On Play] effect, you may select up to 5 of your rested DON!! cards and set them as active.
OP14-032	Humandrill	Does the "When this Character becomes rested" effect activate when this Character attacks?	Yes, it does.
OP14-033	Perona	When this active Character is K.O.'d, can I rest this Character to activate this [On K.O.] effect?	No, you cannot. This [On K.O.] effect can only be activated by resting any other card on your field.
OP14-034	Monkey.D.Luffy	Can I use this [Once Per Turn] effect to rest the Character that is about to be K.O.'d itself?	Yes, you can.
OP14-035	Yosaku	Does the "When this Character becomes rested" effect activate when this Character attacks?	Yes, it does.

OP14-040	Jinbe	When I have 4 rested DON!! cards and 2 or more cards in my hand, can I activate this card's [Activate: Main] effect twice?	Yes, you can.
OP14-041	Boa Hancock	When I play a Character during my opponent's turn, can I choose not to draw a card with this [Opponent's Turn] effect?	No, you cannot. You must draw 1 card in this case.
OP14-044	Edward.Newgate	If I use this [On Play] effect to reveal 1 card from the top of my deck, and the revealed card's type includes "Whitebeard Pirates", what happens to that revealed card?	In this case you would draw 2 cards from the top of your deck, including the revealed card, and then you would trash 1 card from your hand.
OP14-045	Kuroobi	If a card is trashed from my hand by an opponent's [Trigger] effect like "OP09-111 Brook", does this Character gain [Rush]?	Yes, it does.
OP14-048	Shiryu	Do I still have to trash all cards from my hand even if I do not return an opponent's Character to their hand with this [On Play] effect?	Yes, you must trash all cards from your hand.
OP14-048	Shiryu	If this Character was the only card in my hand when I played it, and I have 0 cards in my hand after playing it, can I still use this [On Play] effect to return an opponent's Character to the owner's hand?	Yes, you can.
OP14-049	Jinbe	If a card is trashed from my hand by an opponent's [Trigger] effect like "OP09-111 Brook", does this Character gain [Rush]?	Yes, it does.

OP14-053	Vista	If my Leader is "OP13-002 Portgas.D.Ace" and this card is K.O.'d on my opponent's turn while I have 7 or less cards in my hand, can I use the [DON!! x1] effect on "OP13-002 Portgas.D.Ace" to draw a card, since this card was K.O.'d when its base power had become 6000?	Yes, you can.
OP14-054	Fisher Tiger	Do I still have to trash cards from my hand with this [End of Your Turn] effect when I have 5 or less cards in my hand?	No, you do not. You must trash cards until you have 5 cards in your hand only if you have 6 or more cards in your hand.
OP14-056	Wadatsumi	"When a card is trashed from your hand by an effect, this Character's effect is negated during this turn." Are other effects this Character gained from other cards are also negated by this effect?	No, those effects are not negated.
OP14-057	Don't Worry!! I'm Here!!	After activating this [Main] effect, if I play any {Fish-Men} or {Merfolk} type Characters during this turn, do those Characters gain +1000 power?	No, they do not.
OP14-059	Please Take Me with You!! I Can Be of Great Help to You!!	If I have 3 cards in my hand including this card when I activate this [Main] effect, can I draw 2 cards?	Yes, you can.
OP14-060	Donquixote Doflamingo	Can I choose one of my opponent's Characters with this [On Your Opponent's Attack] effect?	No, you cannot.
OP14-069	Donquixote Doflamingo	If my Leader does not have the {Donquixote Pirates} type and I returned 3 of my DON!! cards from my field to my DON!! deck using this card's [On Play] effect, can I still activate the "Up to 3 of your opponent's Characters with a cost of 7 or less cannot be rested until the end of your opponent's next End Phase." effect?	Yes, you can.

OP14-070	Buffalo	When this Character activates [Blocker], can I use this Character's effect to return 1 DON!! card on my field to my DON!! deck and set this Character as active?	No, you cannot.
OP14-078	Bullet String	If my Leader does not have the {Donquixote Pirates} type, can I use the part of this [Counter] effect that says "Then, that card gains +2000 power during this turn."?	No, you cannot.
OP14-079	Crocodile	Which player's effects is the "your effects" in "All of your opponent's Characters cannot be removed from the field by your effects." referring to?	This refers to the effects of whichever player is using this Crocodile card as their Leader. For example, if this card is your Leader and you activate "EB01-051 Finger Gun", you may use the "trash 2 cards from the top of your deck" effect, but even if you select "1 of your opponent's Characters with a cost of 5 or less", that Character belonging to your opponent will not be K.O.'d.
OP14-079	Crocodile	If I use this [Activate: Main] effect to K.O. one of my Characters, can I activate that Character's [On K.O.] effect if it has one?	Yes, you can. In this case, the "Give up to 1 of your opponent's Characters -10 cost during this turn. Then, you may trash 2 cards from the top of your deck." effect would activate first, and then that Character's [On K.O.] effect would activate.
OP14-080	Gecko Moria	If I use this [Activate: Main] effect to K.O. one of my Characters, can I activate that Character's [On K.O.] effect if it has one?	Yes, you can. In this case, the "Your Leader and all of your Characters gain +1000 power during this turn." effect would activate first, and then that Character's [On K.O.] effect would activate.
OP14-080	Gecko Moria	If I play a Character during the turn after activating this [Activate: Main] effect, does that Character gain +1000 power?	No, it does not.
OP14-082	Oinkchuck	If I play a {Thriller Bark Pirates} type Character after activating this [On K.O.] effect, does that Character gain +4 cost until the end of my opponent's next End Phase?	No, it does not.

OP14-082	Oinkchuck	Can I use this card's [Trigger] effect to play this card itself from my trash?	No, you cannot. Cards are not considered to be in the trash while their [Trigger] effects are being resolved.
OP14-089	Ryuma	Can I use this card's [Trigger] effect to play this card itself from my trash?	No, you cannot. Cards are not considered to be in the trash while their [Trigger] effects are being resolved.
OP14-096	Ground Death	If I have 9 cards in my trash when I activate this [Counter] effect, can I still use the "up to 1 of your Leader or Character cards gains +4000 power during this battle." effect?	Yes, you can.
OP14-098	Crescent Cutlass	If I play a Character with a type including "Baroque Works" after activating this [Main] effect, does that Character gain +3 cost until the end of my opponent's next End Phase?	No, it does not.
OP14-100	Absalom	Can I use this card's [Trigger] effect to play this card itself from my trash?	No, you cannot. Cards are not considered to be in the trash while their [Trigger] effects are being resolved.
OP14-102	Kumacy	Can I use this card's [Trigger] effect to play this card itself from my trash?	No, you cannot. Cards are not considered to be in the trash while their [Trigger] effects are being resolved.
OP14-109	Victoria Cindry	Can I use this card's [Trigger] effect to play this card itself from my trash?	No, you cannot. Cards are not considered to be in the trash while their [Trigger] effects are being resolved.

OP14-110	Dr. Hogback	Can I use this card's [Trigger] effect to play this card itself from my trash?	No, you cannot. Cards are not considered to be in the trash while their [Trigger] effects are being resolved.
OP14-111	Perona	Can I use this card's [Trigger] effect to play this card itself from my trash?	No, you cannot. Cards are not considered to be in the trash while their [Trigger] effects are being resolved.
OP14-112	Boa Hancock	If my Leader does not have the {Seven Warlords of the Sea} type, can I use the "Then, add up to 1 card from the top of your opponent's Life cards to the owner's hand." part of this [On Play] effect?	No, you cannot.
OP14-115	Rindo	If I don't use this [Opponent's Turn] effect to add a card from the top of my deck to my Life cards, do I still take 1 damage?	Yes, you do.
OP14-119	Dracule Mihawk	Does the "When this Character becomes rested" effect activate when this Character attacks?	Yes, it does.
OP14-120	Crocodile	If my opponent only has a Character with a cost of 10 or more, can I use this [On Play] effect to draw 1 card?	Yes, you can.
EB04-011	Scaled Neptunian	If this card is the only {Neptunian} type Character you have, what happens to its [On Play] effect?	In this case, you will draw 1 card, then trash 1 card from your hand.

EB04-011	Scaled Neptunian	Can [Rush: Character] cards attack active Characters on the turn in which they are played?	No, they cannot. They can only attack rested Characters, as described under the regular attack rules.
EB04-015	Jinbe	When this Character is K.O.'d, can I use its [On K.O.] effect to rest itself?	No, you cannot.
EB04-016	Bird Neptunian	After using this card's [Activate: Main] effect, can I use the [End of Your Turn] effect of "OP07-021 Urouge" to set 1 of my DON!! cards as active at the end of my turn?	No, you cannot.
EB04-018	Megalo	If this card is played in a rested state due to an effect, can I still K.O. 1 of my opponent's characters with its [On Play] effect?	No, you cannot.
EB04-022	Isshō	If my opponent has 5 or less cards in their hand, can I still use this card's [On Play] effect to trash 2 cards from my hand?	Yes, you can. In this situation, your opponent does not place 2 cards from their hand at the bottom of their deck in any order.
EB04-034	Charlotte Pudding	If I activate this card's [On Your Opponent's Attack] effect while I have 3 cards in my trash, then use it to discard 1 more card so I have 4 cards in my trash, can I give up to 1 of my Leader or Character cards +2000 power for this battle?	Yes, you can.

EB04-040	Flame Dragon Torch	If none of my Kaido cards are on the field, can I still use this card's [Main] effect to rest 6 of my DON!! cards and 1 of my opponent's Characters?	Yes, you can.
